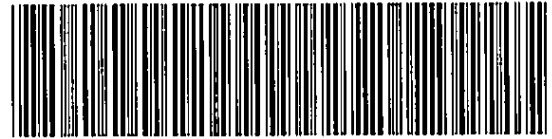

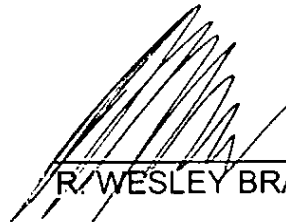
**Certificate of Designation of Registered Agent and Registered Office**
