Address. The mailing address and street address of the principal office of the Company shall be 2206 NE 4th Street 5, Boynton Beach, FL 33435.

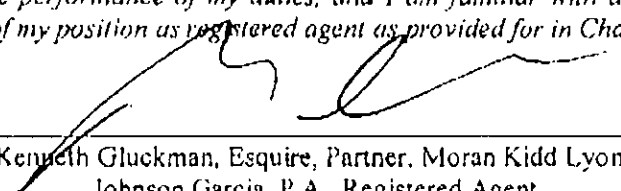
ARTICLE III

Management. The Company shall be managed and controlled by an Authorized Member

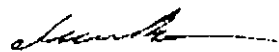
