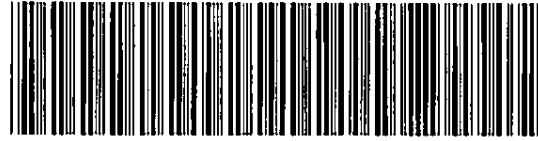

**ARTICLES OF ORGANIZATION

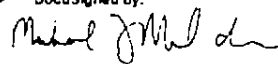
ARTICLE IV: MANAGEMENT OF THE COMPANY

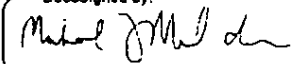

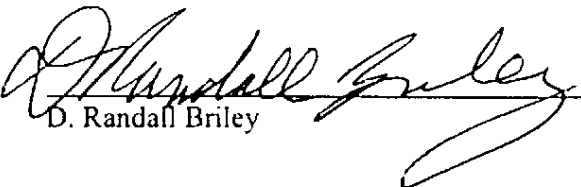
