The undersigned, Marcy Stoudt, a natural person competent to contract and an authorized representative of Revel Search, LLC, hereby presents these Articles of Organization as the Articles of Organization of Revel Search, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Revel Search, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company's initial principal office is 181 San Juan Drive, Ponte Vedra Beach, Florida 32082. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.
