The name of the limited liability company is: **BD Mac Holdings, LLC.**

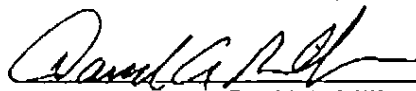
ARTICLE II. ADDRESS
