**ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION
OF
ATOMIC PRECISION PARTNERS, LLC**

Pursuant to the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, **ATOMIC PRECISION PARTNERS, LLC**, a Florida limited liability company (hereinafter, the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

SECOND: The Company's Articles of Organization are hereby amended by deleting Article V of the Articles of Organization and replacing it with the following new Article V:
