The undersigned, acting as the authorized representatives, do hereby certify that the person so identified herein has formed a limited liability company (the "Company") under the laws of the State of Florida and under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes as amended (the "Act"), and pursuant to the Act, hereby sets forth the following Articles of Organization (these "Articles"):

**ARTICLE I: NAME**

The name of the Company shall be ADSA Family Investments, LLC.

**ARTICLE II: ADDRESS AND PLACE OF BUSINESS**

The initial address of the principal office and the mailing address of this Company shall be: 3023 Bellwind Circle, Rockledge, FL 32955.

**ARTICLE III: DURATION AND PURPOSE**

The initial members of the Company, through their undersigned authorized representative, do hereby certify that the foregoing constitutes the articles of organization of ADSA Family Investments, LLC.






