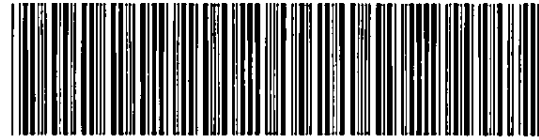

**ARTICLES OF ORGANIZATION OF

**ARTICLE I
NAME**

The name of the limited liability company shall be **2351 Douglas Road # 709, LLC** (the "Company").

**ARTICLE II
MEMBERS**

The Company shall have one or more members (the "Members").

STREET ADDRESS OF PRINCIPAL OFFICE**

A Member's interest in the Company shall be considered personal property, notwithstanding the actual nature of the assets owned by the Company, and may not be sold or otherwise transferred except in strict accordance with the Operating Agreement of the Company.

MANAGEMENT**


