The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 605 of the Florida Statutes (the "Act").

1. **NAME.** The name of this limited liability company (the "Company") is **Waterfront Getaway, a Boating Paradise, LLC.**

2. **EFFECTIVE DATE AND DURATION.** The existence of the Company shall commence on September 14, 2023. The period of duration of the Company shall be perpetual.




