**ARTICLES OF ORGANIZATION
OF
THE HOUSE OF UNIFORMS, LLC**

The undersigned, being an authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, do hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is **THE HOUSE OF UNIFORMS, LLC** (the "Company").

**ARTICLE II

REGISTERED AGENT AND OFFICE**

The Company designates 828 NW 24th Court, Miami, Florida 33125 as the street address of the initial registered office of the Company and names Abisai Hernandez as its initial registered agent at that address to accept service of process within this state.

DURATION AND CONTINUATION**

The Manager(s) shall serve in such capacity until his, her, or their successor(s) is/are duly elected and qualified.

OPERATING AGREEMENT**




