ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF

FINDERS DIVERSIFIED INTERNATIONAL, LLC, a Florida limited liability company (the "Company"), whose Articles of Organization were originally filed with the Florida Department of State effective as of December 27, 2023 (Florida Division of Corporations Document Number L24000000136), hereby certifies as follows:

1. The Company's Articles of Organization are hereby amended by deleting the present form of Article I in its entirety and Article V in its entirety, and by substituting, in lieu thereof, each of the following:

"ARTICLE I
NAME & ADDRESS

"ARTICLE V
