

ARTICLES OF ORGANIZATION

OF

PATRICIA HASKELL, PLLC

Pursuant to (i) the Florida Revised Limited Liability Company Act, Chap. 605, Florida Statutes, and (ii) the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, the following are adopted as the Articles of Organization of the professional limited liability company organized hereby:

ARTICLE I - NAME

The name of the limited liability company (the "Company") shall be Patricia Haskell, PLLC.

ARTICLE II - ADDRESS

The mailing address and the street address of the principal office of the Company shall be 1877 Atlantic Beach Drive, Atlantic Beach, Florida 32233.

ARTICLE III - REGISTERED AGENT


