The undersigned, Dustin Vaughn, a natural person competent to contract and an authorized representative of Local Pen, LLC, hereby presents these Articles of Organization as the Articles of Organization of Local Pen, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is Local Pen, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**
