AMENDED & RESTATED ARTICLES OF ORGANIZATION

OF

GARNER THOMAS PROPERTY CO., LLC

a Florida limited liability company

ARTICLE U NAME: APPLICABLE LAW

The name of the limited liability company formed pursuant to the filing of these Articles of Organization (the "Articles") is "GARNER THOMAS PROPERTY CO., LLC" (the "Company"). The Company is created pursuant to and in accordance with the Florida Revised Limited Liability Company Act, Chapter 605. Florida Statutes (as amended from time to time, the "LLC Ad"). The Company and its internal affzirs shall be governed exclusively by the LLC Act and the laws of the State of Florida.

Among other things, the Operating Agreement restricts the sale, transfer, pledge, hypothecation, exchange, assignment or other disposition by any means, including but not limited to those which are voluntary, involuntary, by operation of law, by the laws of descent and distribution, or otherwise (each, a "Transfer"), of the limited liability company membership interests in the Company. Any such Transfer shall be void ab initio unless made in strict compliance with the terms and conditions of the Operating Agreement.
