OF

The undersigned, Jason White, a natural person competent to contract and an authorized representative of a member of Beachy Connections, LLC, hereby presents these Articles of Organization as the Articles of Organization of Beachy Connections, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Beachy Connections, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The registered office of the Company is 90 Seascape Drive, Unit 102, Miramar Beach, Florida 32550 and the name of the registered agent at that address is Jason White.

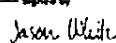
ARTICLE VI - MANAGEMENT

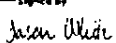
