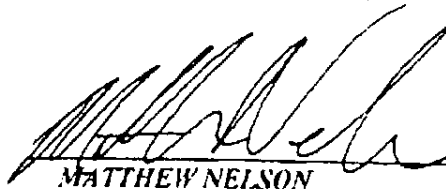

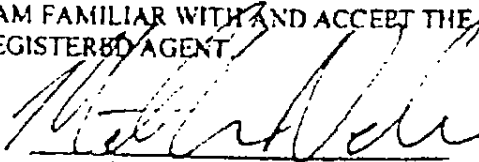
The Company may exercise any powers, without limitation whatsoever, which a Limited Liability Company may legally exercise under the laws of the State of Florida.
