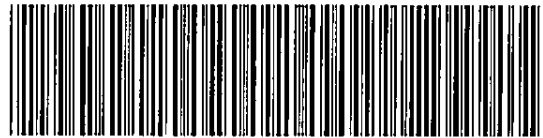

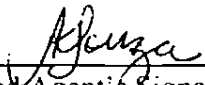

This conversion becomes effective upon filing with the Secretary of State of **FLORIDA** and **ILLINOIS**, or as otherwise required by law.

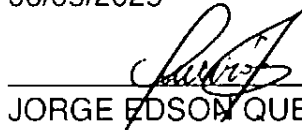
