ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

The Articles of Incorporation of the undersigned corporation were originally filed on December 18, 1989. Pursuant to the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is MSA/Associates, Inc. (the "Corporation").
