ARTICLES OF AMENDMENT OF
ARTICLES OF INCORPORATION OF

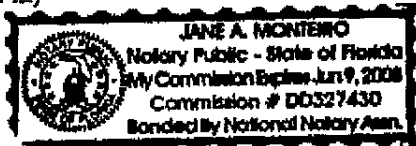
