TANGERINE REALTY CORPORATION**

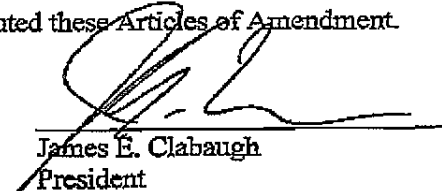
