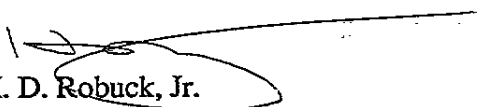

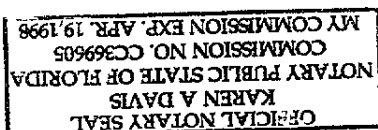

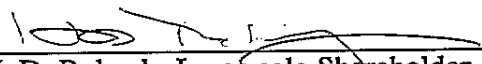

BY WRITTEN CONSENT OF ALL THE SHAREHOLDERS**

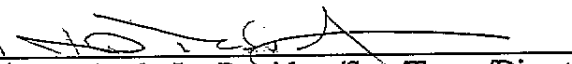
