We discussed by telephone with your representatives the circumstances surrounding the administrative dissolution of Interaxx Television Network, Inc.; document number L87340. We have enclosed the amount of \$652.50 to accomplish the above actions and request that the following circumstances be considered as sufficient to waive the \$600.00 reinstatement fee. This corporation was inadvertently dissolved in 1999 for failure to file an annual report. It was presumed that the corporate staff had filed the annual report at the proper time and it apparently was not. We do note that the sole officer and director of the Company, Mr. Golasa, passed away in October 2000 and prior to that, the company had filed for protection under Chapter 11 on March 26, 1999 (Case No. 9931551-BKC-PGH Southern District of Florida). At his sudden passing, operations were disrupted and confused and the address of the corporation was changed but without proper notification to the State and subsequent Annual Report forms went missing. More confusion ensued and the requirement to file an Annual report was unintentionally overlooked.

When these elements were discovered by the successors of the Company, and the remedies made known, we contacted your department seeking the waiver of the reinstatement fee due to these extraordinary circumstances.
