5. The 1994 and 1995 reports also had incorrect zip codes. The reports had zip code corrections when filed, however, the Department of State records were not corrected.

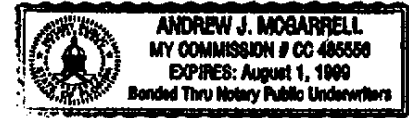
