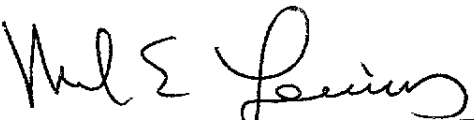
1. The name of the Corporation is LEWIS, ROSENTHAL & GOTLIEB, M.D., P.A..

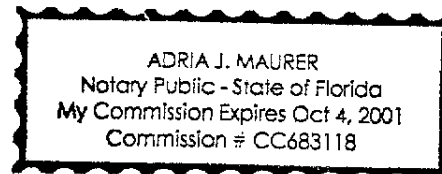
