The undersigned, for the purpose of forming a limited liability company in compliance with Section 608.407 of the Florida Statutes, hereby adopts the following Articles of Organization.

**ARTICLE I - NAME**

The name of this limited liability company is **NOAH'S ANIMAL HOSPITAL MANAGEMENT, L.C.**

**ARTICLE II - DURATION**

This limited liability company shall exist until May 7, 2023 at which time this limited liability company shall terminate and cease to exist.





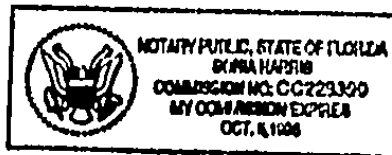
