The limited liability company's duration is perpetual.

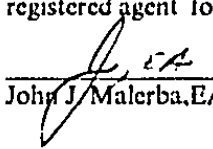
ARTICLE 3 - POWERS

The remaining members shall admit new members under terms set forth in the regulations of this limited liability company.

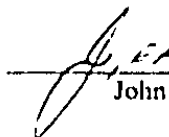
ARTICLE 8 - MEMBERS' RIGHTS TO CONTINUE BUSINESS
