ARTICLES OF ORGANIZATION OF TRANSMODAL FREIGHT SYSTEMS (FLORIDA), L.C.

THE UNDERSIGNED hereby certifies that the members of the limited liability company formed hereby have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.
