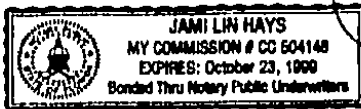

**Name**

##### Continuation of Business

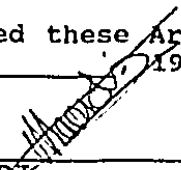
