**ARTICLES OF ORGANIZATION

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under Chapter 608, Florida Statutes, the Florida Limited Liability Company Act.

**Article 1 – Name**

The name of the limited liability company is RC Racing, L.C., (the "Company").

**Article 2 – Address**

The mailing address and street address of the principal office of the Company is Route 1 Box 3323 W, Havana, Florida 32333.

**Article 3 – Duration**

The Company shall exist from the date of filing these Articles with the Department of State until the earlier of thirty (30) years from the date of filing or the occurrence of any of the events specified in Section 608.441, Florida Statutes, unless continued by the members pursuant to Company regulations.

**Article 4 – Registered Agent and Office**

**Article 5 – Admission of Additional Members**

Additional members may be admitted to the Company pursuant to Company regulations.

**Article 6 – Termination of Membership**

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may continue the business of the Company pursuant to Company regulations.
