The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be GALILEO BUSINESS SOFTWARE, L.C. (the "Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company shall be 800 Douglas Road, Suite 550, Coral Gables, Florida 33134.
