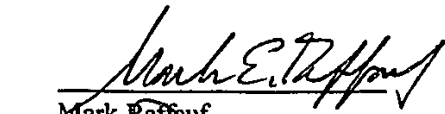
**ARTICLE VI**  
**Admission of New Members**

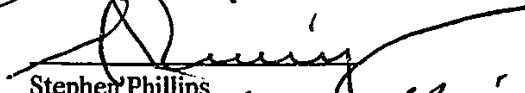
