THESE ARTICLES OF ORGANIZATION are hereby adopted by the undersigned member of this limited company for pecuniary profit under the Florida General Limited Liability Company Act. STATE FLORIDA

ARTICLE I  
NAME AND LOCATION OF AGENT AND OFFICES

Section 1.1 Name. The name of the limited liability company shall be FLORIDA WESTCOAST LEASING & CONSULTING, L.C.

Section 1.2 Principal Office and Place of Business. The principal office of the limited liability company shall be located at 226 Golden Gate Point, Sarasota, Florida, 34236, with a post office address which is P. O. Box 969, Sarasota, Florida, 34230. The principal place of business of the limited liability company shall be the same as the principal office. The limited liability company may change the location of the foregoing offices or the post office address, transact business at other places within or without the State of Florida and establish branch offices within or without the State of Florida, all as the Members may from time to time determine.

ARTICLE II  
DURATION AND COMMENCEMENT

Section 2.1 Duration. The limited liability company shall have perpetual existence, or until dissolved according to law.

Section 2.2 Commencement of Limited Liability Company Existence. The limited liability company's existence shall commence on the date of subscription and acknowledgment hereof which date shall be no more than 5 days prior to the filing hereof by the Department of State.

ARTICLE III  
PURPOSE AND POWERS

Section 3.1 Purpose. The general purpose for which the limited liability company is initially organized shall be to transact any and all lawful business for which a limited liability company may be incorporated under the laws of Florida, and to do everything necessary or convenient for the accomplishment of said purpose, and to do all other things incidental thereto or connected

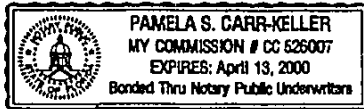
