**ARTICLES OF DISSOLUTION
FOR
INTERQUEST ONLINE L.C., A FLORIDA LIMITED LIABILITY COMPANY**

1. The name of the limited liability company is InterQuest Online L.C.
2. The effective date of the limited liability company's dissolution is January 19, 2000.
3. A description of the occurrence that resulted in the limited liability company's dissolution pursuant to section 608.441, Florida Statutes, is as follows:

Section 608.441 (1) (b), Florida Statutes specifies that:

"(1) A limited liability company organized under this chapter shall be dissolved, and the company's affairs shall be concluded, upon the first to occur of any of the following events:

(b) Upon the occurrence of events specified in the articles of organization or operating agreement[.]"

Article VI of InterQuest Online L.C.'s Articles of Organization states that:

"The death, insanity, bankruptcy, retirement, resignation or expulsion of a member shall cause the dissolution of the Company, except that all remaining members of the Company may vote within 30 days after any of these events to continue the legal existence of the Company, in which case the Company shall not dissolve."

On or about November 4, 1999 Janet Sue Godfrey resigned as a member of InterQuest Online L.C. A copy of her resignation is annexed to this Certificate. On or about November 5, 1999 Jill Christi Young resigned as a member of InterQuest Online L.C. A copy of her resignation is annexed to this Certificate. The sole remaining member and managing member Maria Isabel Velez, who is executing these Articles of Dissolution has not voted to continue the legal existence of InterQuest Online L.C. and therefore requests that these Articles of Dissolution be accepted for filing and InterQuest Online L. C. be dissolved.

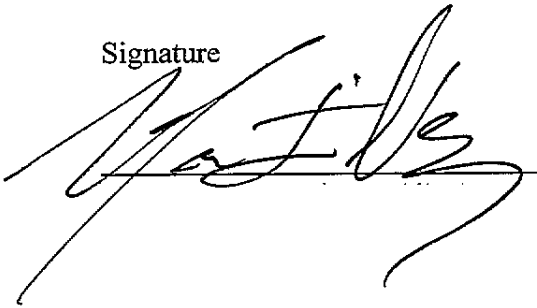

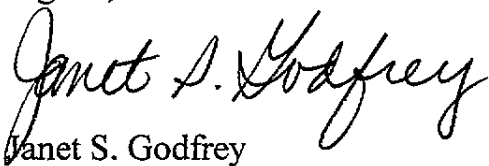
RE: My Status Within InterQuest Online, LLC.

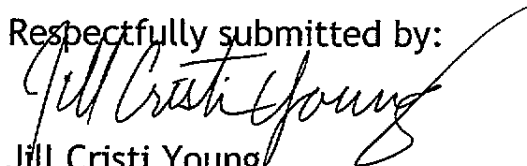
Re: Membership Status of Jill C. Young in InterQuest Online, LLC
