ARTICLE V - Admission of Additional Members:

The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be:

- (1) All members agree equally and fully on the admittance of any and all other members.
- (2) If one member should disagree on the admittance of a new member no admittance into the L.L.C. shall be granted.
- (3) If admittance of a new member is granted it shall be understood that it will be for a trial period of 90 days. At the end of the 90 days if the new members input into the L.L.C. is unsatisfactory it will be at the full acceptance of each managing member before him, that he or she shall be dismissed from the L.L.C.
- (4) If admittance of a new member is granted it is understood that their share shall be decided by upon any ~~and all~~ existing managing members.
- (5) The needed amount to buy in as a partial owner will be determined at the time of acceptance it will be based on actual L.L.C. value and holdings at the time.

ARTICLE VI - Members Rights to Continue Business:

The right, if given, of the remaining members of the limited liability company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company shall be:

(2) 30% to Avery Johnson in the exact fashion and terms as pertain to Jimmie Jr. in the above article.

(3) 30% to Michelle Johnson.

(4) 10% to Eunae Yu.

II. (1) Michelle E. Johnson

In the event that such occurrence should take place Michelle would like for her share of 22.5% to be dispersed in this fashion.

(2) 30% to Jimmie Johnson Sr.

(3) 30% to Jimmie Johnson Jr. with the conservator until he is the age of 25 if such should happen that Jimmie is deceased it shall be given directly to Jimmie Johnson Jr.

(4) 30% to Avery Johnson in the exact fashion and terms as pertain to Jimmie Jr. in the above article.

(5) 10% to be split equally between Amanda and Shelby Leech 5% each with the conservator as Michael and Elizabeth Leech until they are age 25 if such should happen that Michael and Elizabeth are deceased the conservator shall be Jimmie Johnson Sr.

III. (1) Michael Leech


