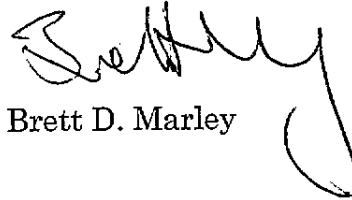

All remaining property and assets have been distributed between the Company's members in accordance with their respective rights and interests.

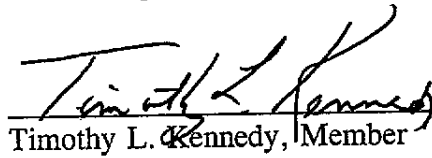
