- FIRST:** The date of filing of the Articles of Organization was January 30, 1998.
- SECOND:** The following amendment(s) to the Articles of Organization was/were adopted by the limited liability company:

**ARTICLE IV is amended as follows:**

**"ARTICLE IV**

The street address and mailing address of the principal office for the conduct of business of the limited liability company shall be c/o St. Petersburg Neighborhood Housing Services, Incorporated, 1600 Dr. Martin L. King Street S., St. Petersburg, Florida 33701."

**ARTICLE V is amended as follows:**
