**ARTICLES OF ORGANIZATION
FLORIDA CITRUS INTERNATIONAL - DEVELOPMENT,
L.C.**

The undersigned adopt the following Articles of Organization for the purpose of becoming a limited liability company under the Florida Limited Liability Company Act:

**ARTICLE I
NAME**

The name of the limited liability company, referred to in these Articles as "Company" is **FLORIDA CITRUS INTERNATIONAL - DEVELOPMENT, L.C.**

**ARTICLE II
DURATION**

The company shall continue in existence for thirty (30) years from the date of filing of these Articles of Organization with the Department of State, unless sooner dissolved.

**ARTICLE III
PURPOSE**

This limited liability company is organized for the purpose of acquiring, developing and marketing citrus groves in the State of Florida, and for the purpose of growing, harvesting and marketing a variety of citrus products, and undertaking all activities related thereto, as well as to transact any or all lawful business for which limited liability companies may be organized under the Florida Limited Liability Company Act.

**ARTICLE IV
PRINCIPAL ADDRESS**

The address of Company's principal place of business in Florida as well as its mailing address is 1682 State Road 64 West, Wauchula, FL 33873.

**ARTICLE V
REGISTERED AGENT AND OFFICE**

The name of the Company's initial registered agent in Florida is Klaus Kunkel. The address of Company's registered office in Florida is 1682 State Road 64 West, Wauchula, FL 33873.

**ARTICLE VI
CAPITAL CONTRIBUTIONS**

The total amount of property to be contributed by each member shall be at least \$10,000.00

Contributions to the Company by each member are as follows:

- (a) F & H Citrus, Inc. has made a cash contribution of \$20,000.00.
- (b) Klaus and Dagmar Kunkel have made a cash contribution of \$10,000.00.

**ARTICLE VII
ADDITIONAL CONTRIBUTIONS OF MEMBERS**

In the event of a catastrophe additional contributions may be required of members in amounts not to exceed US\$1,000.00 per membership unit, but only upon the affirmative vote of 100% of the membership units then outstanding.

**Article VIII
Members**

The limited liability company shall have two (2) members. F & H Citrus, Inc., a Florida corporation, shall own 2/3 of the company and Klaus Kunkel and Dagmar Kunkel shall own 1/3 of the company. Ownership of the limited liability company or any corporate entity which is a member may be transferred to the immediate family members of Klaus Kunkel, Dagmar Kunkel, Günter Fanta, or Dieter Hofmann.

**ARTICLE IX
RIGHT TO CONTINUE BUSINESS**

The remaining members of the limited liability company may continue to do the business of the company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company.

**ARTICLE X
MANAGEMENT**

The company is to be managed by two (2) members. The following initial members are elected to serve as managing members until the first annual meeting of the members or until their successors are elected and qualified:

**ARTICLE XI
RESTRICTION ON MANAGEMENT**

The managing members shall not have the authority to sell or mortgage real estate which is the property of the company unless the action has been authorized by an affirmative vote of 100% of the membership units then outstanding at a regular meeting of the members or a special meeting duly called for that purpose. The two managing members shall have the authority to sell or mortgage the citrus fruit crop and to caretake the grove at a good level of care.

**ARTICLE XII
WITHDRAWAL FROM THE COMPANY**

A member may withdraw from the company at any time. However, a withdrawing member's membership units are subject to repurchase at 80% of their fair market value, as determined by an appraisal, and the members may impose other restrictions as well.

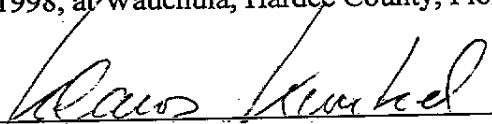
**ARTICLE XIII
VOTING**

Voting on all issues brought before the membership shall be based on membership units and not on the size of each member's capital account.

**ARTICLE XIV
POWER TO ADOPT, ALTER, AMEND OR REPEAL REGULATIONS**

The power to adopt, alter, amend or repeal the regulations of this limited liability company shall be vested in the members of this company.



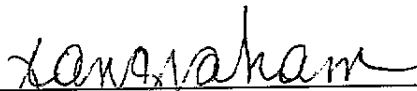
