
Article I is hereby amended to read as follows:


**ARTICLE I**

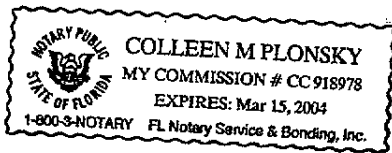

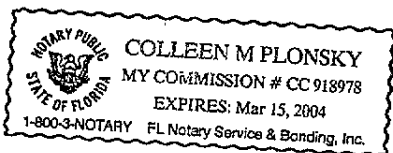
