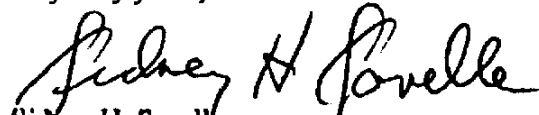
Gentlemen:
