This letter is to inform the Florida Division of Corporations of my desire to dissolve the Limited Liability Company called DeSilva Reporting.

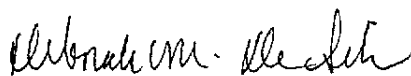
I am the only member of this LLC, and I would like it dissolved as of the date of the writing of this letter, 1/6/04.
