**CERTIFICATE OF AMENDMENT
TO ARTICLES OF ORGANIZATION OF
DELAND PROFESSIONAL CENTER, L.C.**

The Articles of Organization of DeLand Professional Center, L.C., a Florida limited liability company (the "Company"), are amended as set forth in this Certificate of Amendment:

1. The name of the Company, until amended as provided herein, is DeLand Professional Center, L.C.
2. The date of filing of the Company's Articles of Organization was October 20, 1998.
3. The purpose of this Certificate of Amendment is to change the name of the Company from DeLand Professional Center, L.C. to Port Orange Medical Center, L.C.
4. Article I of the Articles of Organization of the Company is hereby amended to read as follows:

"ARTICLE 1
NAME

The name of this company is Port Orange Medical Center, L.C."

5. This amendment was adopted by the members of the Company on the date of execution of this certificate, and the number of votes cast for the amendment by the shareholders was sufficient for approval.
6. This amendment is made pursuant to Sections 608.411, Florida Statutes.
