**ARTICLES OF ORGANIZATION OF
METAL LINK, L.C.**

ARTICLE I

The name of this Limited Liability Company shall be Metal Link, L.C., a limited liability company.

ARTICLE II

Metal Link, L.C. shall exist for a period ending on December 31, 2040.

ARTICLE III

ARTICLE VII

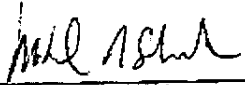

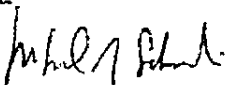

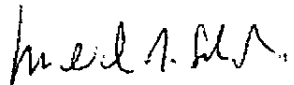
