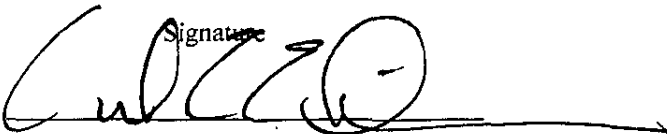

The terms of the Stipulation do not constitute a compromise.

NOTICE OF OPPORTUNITY TO OBJECT AND FOR HEARING

Pursuant to Local Rule 2002-4, the Court will consider this motion, objection or other matter without further notice or hearing unless a party in interest files an objection within 21 days from the date of service of this paper. If you object to the relief requested in this paper, you must file your objection with the Clerk of the Court at Sam M. Gibbons United States Courthouse, 801 N. Florida Avenue, Suite 727, Tampa, Florida 33602 and serve a copy on Robert E. Tardif Jr., Trustee, Post Office Box 2140, Fort Myers, FL 33902, and on the Assistant United States Trustee, 501 E. Polk Street, Suite 1200, Tampa, Florida 33602.

If you file and serve an objection within the time permitted, the Court will schedule a hearing and you will be notified. If you do not file an objection within the time permitted, the Court will consider that you do not oppose the granting of the relief requested in the paper and will proceed to consider the paper without further notice or hearing and may grant the relief requested.

WHEREFORE the Trustee moves the Court to enter an appropriate Order approving the terms of the Stipulation and directing that the Debtor comply with the terms of the Stipulation.

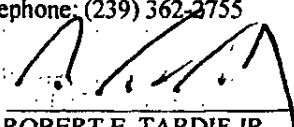
STIPULATION ON REPURCHASE OF ASSETS

1. The Debtor shall be entitled to repurchase the following non-exempt property by paying the total amount of \$8,850.00 payable over 12 months: LTT Investments, Inc., office furniture and equipment. The Debtor shall pay \$ 737.50 beginning August 15, 2011, and continuing on the same day of each month thereafter for a total of 11 months. The Debtor shall make a final monthly payment of \$737.50. All payments shall be mailed and be made payable to Robert E. Tardif Jr., Trustee, Post Office Box 2140, Fort Myers, FL 33902. If the Debtor pays more than the total amount referenced above, the Trustee is permitted to deposit and administer the funds. The Trustee may deposit post-dated checks upon receipt.

2. In the event any payment is not made, the Trustee shall give written notice to the Debtor and Debtor's counsel, at the last address of record. If the Debtor fails to cure the default within ten days from the date of the letter, the Trustee shall have the right to accelerate the remaining balance due and to file a Motion for Entry of Final Judgment for said sums together with estimated attorney's fees and costs for the need to file an adversary proceeding to deny or revoke the Debtor's discharge. A Final Judgment based on the Motion shall be entered without further notice or hearing. Further, the Trustee shall have the right to file suit seeking the revocation or denial of the Debtor's discharge, as appropriate, due to the Debtor failing to comply with the terms of the Stipulation.

3. This Stipulation is subject to filing a Motion to Approve Stipulation and no objections or higher bids being received. If a higher bid is received, the Trustee shall notify the Debtor to arrange an auction. In the event the Debtor is not the high bidder for any property being repurchased at private sale, the Debtor will receive a refund of any funds paid by the Debtor for said property.
