ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I — NAME

The Name of the limited liability company shall be Stilwell Management, L.L.C. ("Company").

ARTICLE II — ADDRESS

Proc. 94-46.
