ARTICLES OF ORGANIZATION

OF

NATIONAL DIVERSIFIED INSURANCE AGENCY, L.C.

The undersigned acting as organizer of U.S.A. DIVERSIFIED INSURANCE AGENCY,L.C., under the Florida Limited Liability Company Act, adopt the following Articles of Organization for said limited liability company.

ARTICLE I
NAME

The name of the limited liability company shall be NATIONAL DIVERSIFIED INSURANCE AGENCY, L.C., (the "LLC").

ARTICLE II
DURATION

This LLC shall exist perpetually, unless dissolved according to law or as set forth in the LLC's Operating Agreement.

ARTICLE III
PURPOSE

The LLC is organized pursuant to the Florida Limited Liability Company Act for the purpose of conducting any lawful activity in Florida, with the powers described in the Florida Limited Liability Company Act and as set forth in the LLC's Operating Agreement.

**ARTICLE VI

Additional members may be admitted to the LLC upon the majority consent of all members in proportion to their contributions to the capital of the LLC, as adjusted from time to time to properly reflect any additional contributions or withdrawals by a member, in writing and then only upon the condition that a new member be bound by and become party to the Operating Agreement of the LLC.

**ARTICLE VII
DISSOLUTION, CONTINUATION**

The members shall have the right to continue the LLC upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or occurrence of any other event which terminates the membership of a member in the LLC, so long as the remaining members agree to continue the LLC.

**ARTICLE VIII
MANAGEMENT**


ARTICLE IX
