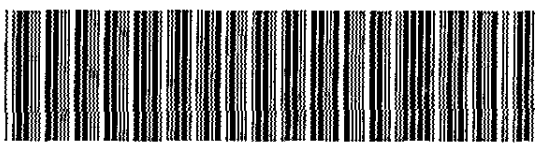

ARTICLE I NAME

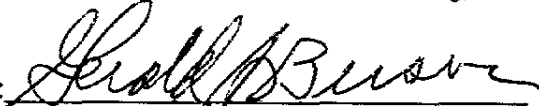
The name of the Limited Liability Company is **Shoppes of Blue Lake II, LLC**.

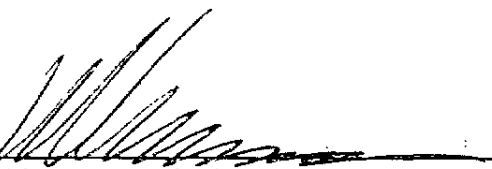

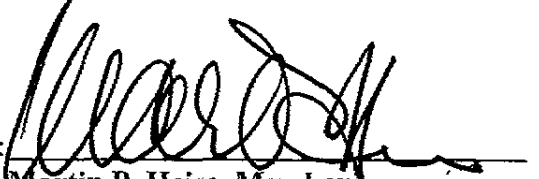
