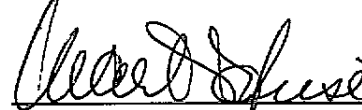
**ARTICLE VII

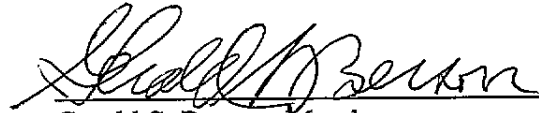

## Exhibit "A"

3.4 *Additional Members.* Additional Persons may be admitted to the Company as Members and Membership Interests may be created and issued to those Persons and to existing Members only with the written consent of a Majority in Interest of all of the Members. The terms of admission or issuance must specify the Sharing Ratios applicable thereto and may provide for the creation of different classes or groups of Members and having different rights, powers, and duties. The Members shall reflect the creation of any new class or group in an amendment to this Agreement indicating the different rights, powers, and duties, and such an amendment need be executed only by the Members. Any such admission also must comply with the provisions of subsections 3.3 (c) (i) and (ii) and is effective only after the new Member has executed and delivered to the Members a document including the new Member's notice address, its agreement to be bound by this Agreement, and its representation and warranty that the representations and warranties in Section 3.2 are true and correct with respect to the new Member. The provisions of this Section 3.4 shall not apply to Dispositions of Membership Interests.
