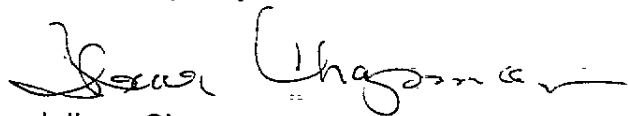

NAME

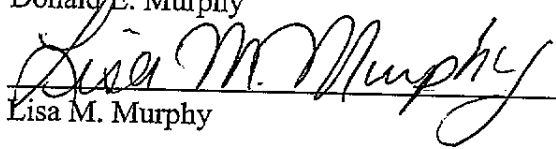
