ARTICLES OF ORGANIZATION
OF
BEACHES INTERNAL MEDICINE, LLC

The undersigned adopt the following Articles of Organization for the purpose of becoming a limited liability company under the Florida Limited Liability Company Act.

ARTICLE I. - NAME

The name of the limited liability company, referred to in these Articles as "Company", is BEACHES INTERNAL MEDICINE, LLC.

ARTICLE II. - DURATION

The Company shall exist perpetually, beginning on the date these Articles of Organization are filed with the Secretary of State.

ARTICLE III. - MAILING ADDRESS

**ARTICLE IV. -

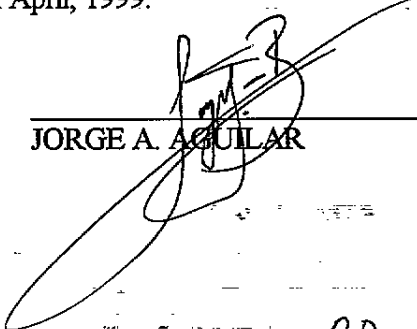

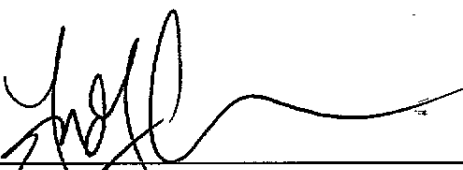

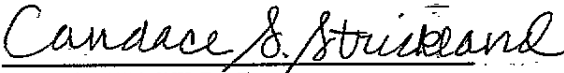
