Article 1. Name

The name of the Limited Liability Company is:

Article 2. Duration

The duration of the Limited Liability Company is perpetual.

Article 3. Principal Office and Mailing Address

Article 7. Right to Continue Business

Upon the retirement, resignation, expulsion, bankruptcy, or dissolution of the sole Member or the occurrence of any other event which terminates the continued membership of the sole Member in the Limited Liability Company, the sole Member's successor-in-interest may elect to continue the business upon the affirmative consent of the sole Member's successor-in-interest.

Article 8. Statement of Management

Article 10. Regulations

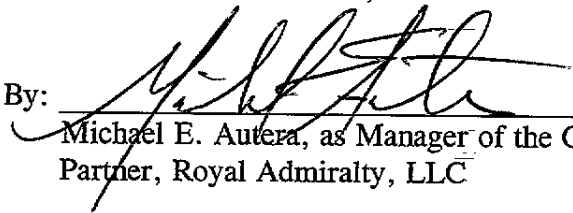

3. The initial amount of cash to be contributed to the Limited Liability Company by the sole Member is \$1,000.00.

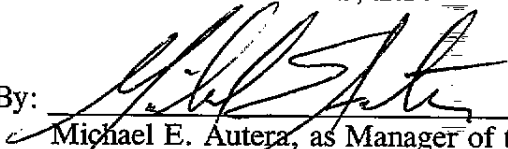

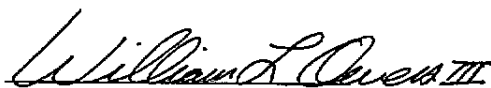
